Lee BeckSenior Advisor for Advocacy and Communications, Global CCS Institute

Lee Beck is currently the Global CCS Institute's senior advisor for advocacy and communications based in the Institute's Washington, DC office. In her role, Lee works closely with diverse stakeholders in North America and globally to advocate on behalf of and strengthen the understanding of carbon capture and storage and its role in delivering vital emissions reductions vis-à-vis global climate goals.

Before joining the Global CCS Institute in mid-2018, Lee was a public relations project manager at VEIC, a nonprofit which addresses the economic and environmental costs of energy consumption through the adoption of energy efficiency and renewables. She began her career as a journalist writing features and reporting from Germany, Italy, Tanzania, and Hong Kong on a variety of political and social issues before gathering experience in a variety of global energy issues such as natural gas markets, energy and climate diplomacy, and the German Energiewende.

Lee earned her BA in liberal arts from the University College Maastricht in the Netherlands and has a master of arts in international affairs and economics with a double-major in energy, resources, and environment and political economy from Johns Hopkins University's School of Advanced International Studies. conservative solutions to address the United States' need for abundant and reliable energy, while CRES Forum is a nonprofit organization launched in 2017 committed to educating the public and influencing the national conversation about commonsense clean energy via advanced educational tools that foster robust conversation, policy development, and advocacy in support of free-market, clean energy solutions across the political spectrum.

Prior to joining CRES and CRES Forum, she was the development director at Student Veterans of America, a nonprofit focused on addressing the needs and concerns of American military veterans in higher education. Before moving into the nonprofit sector, Kelsey worked as deputy finance director for the Pennsylvania Republican Party, regional field director of Southeast Missouri for the RNC Victory Campaign, and as finance director on congressional campaigns in Kansas City, MO, and Fort Lauderdale, FL.
