US Internal Revenue Service's (the "IRS") promulgation of regulations under Section 871(m) of the US Internal Revenue Code of 1986

Dear Client:

This letter is to notify you that, in light of the US Internal Revenue Service's (the "IRS") promulgation of regulations under Section 871(m) of the US Internal Revenue Code of 1986 ("the Rule"), RBC, effective January 1<sup>st</sup> 2017, will not accept any orders from you in the non-exempt equity futures Contracts described in the Rule listed on Schedule A, subject to change from time to time on the following link: <https://www.rbccm.com/assets/rbccm/docs/legal/futures/871m-futures-customer-notification-letter.pdf>. It is your responsibility to review the list and ensure that the Contracts you wish to trade are not on Schedule A before placing an order.

The major equity index futures are not impacted by the regulations and RBC will be able to clear these for you. The regulations impact a small subset of non-exempt equity indices. These contracts tend to have significantly less open interest than the benchmark products.
